International Observers Accreditation Procedures and Code of Conduct House of Representative And Provincial Election 2017 (2074)

International Observers Accreditation procedures

Introduction

This document contains the instructions and forms required for obtaining international observer accreditation for the House of Representative and Provincial Election, 2017 (2074).

You are requested to follow the procedure as below to obtain accreditation for the observers:

Step 1: Accreditation for the observer group:

- a. Read the enclosed "Code of Conduct for International Observers" and ensure that you are in agreement with the provisions therein.
- b. Submit the completed "Application for Accreditation for International Observation" (enclosed) to the Observation Liaison Office (the Elections Observation Resource Centre) of the Election Commission.
- c. Together with the above application, submits the completed "Authorisation Form for the Point of Contact" (enclosed) with one passport size photograph. This form will identify the person acting on behalf of the observer group with whom the Observation Liaison Office (the Elections Observation Resource Centre) will interact on observation matters. Please also attach a copy of the person's passport.

The application of observer group will then be reviewed by the Election Commission for final accreditation. International observers for House of Representative and Provincial Election, 2017 should meet the following requirement for accreditation:

- a. Applicant / individual/ institution/ organisation should produce evidence of registration with the relevant authority of own country
- b. The applicant / organisation/ institution should be working for peace building, good governance and promotion of democratic elections.
- c. The applicant / organisation should commit to fully comply with the electoral code of conduct issued by the Election Commission Nepal.
- d. If the applicant institution/organisation is convicted of any wrong doing, or written allegation or other evidence by the ECN or Government of Nepal it will not be processed for accreditation
- e. Election Commission Nepal reserves the right of accreditation.

Step 2: Accreditation for the individual observers

Once the observation group itself has been accredited, the application for the individual observers can then be processed. In order to do so, the following document must be submitted for each observer:

- a. The completed "Declaration and Pledge of International Observer" form (enclosed) along with a passport size photograph and copy of the passport.
- b. CV of observer should be certified by the concerned observation organisation.
- c. Copy of any publication related on election observation
- d. The stack of forms submitted must have a cover page on the observation group's letterhead with a simple listing of the name of each observer and his/her nationality in the sequence in which the completed forms are enclosed.
- e. Applicant can apply directly online and ECN will inform whether the application has been received, or needs further information to furnish. but, the applicant organisation should submit hard copy of required evidence to start accreditation process
- f. If any international observers' Group intends to mobilize their local staff (Nepali) they also need to undergo the due process of accreditation.

The applications for the individual observers can be submitted at the same time as the application for the observer group itself is submitted (See Step 1). However, accreditation to the individual observer will be provided after observer group obtains the accreditation.

Some groups may have to make several submissions on behalf of individual observers. The Election Commission asks that the number of submissions is kept to a minimum.

Step 3: The Issuance of observer accreditation cards

Once the applications for the individual observers have been approved by the Election Commission, accreditation cards will be prepared for each of the observers. When the observer accreditation cards are ready, the contact person of the observation group will be contacted to collect them and the contract person will then be responsible for their distribution. The layout of the cards is illustrated on the enclosed "Sample of Accreditation Card."

Further Instructions:

- a. All applications are to be delivered in person by the authorized contact person of the observer group directly to the Observation Liaison Office of the Election Commission.
- b. A final submission date for the above applications will be established.
- c. The Election Commission will provide an information kit to each observer with minimum required information.

Please note that the Election Commission expects the observer group to provide each observer with comprehensive training on electoral system and the Code of Conduct to be used for House of Representative and Provincial Election, 2017.

Election Code of Conduct for International Observers

1.1 Preamble

In exercising the powers conferred by Section 6 sub-section 4 of the Election Commission Act, 2017(2073), the following Code of Conduct has been promulgated by the Election Commission of Nepal in order to regulate observer for "House of Representatives and Provincial Elections, 2017" of Nepal to be held on the 26th day of the month of November, 2017 (10th of Mangsir of the year 2074) and 7th December 2017 (21st Mangsir 2074 B.S.). This Code of Conduct shall be binding for all Observer Groups, their associated observers and individual observers accredited by the Election Commission of Nepal (hereinafter referred to as "ECN").

1.2 Accreditation

The following provisions have been established by the ECN with regard to the accreditation of international observers:

- 1. For the purpose of this Code of Conduct, an observer is a person who is part of an international observation group duly accredited by the ECN.
- 2. Accreditation shall be applied according to the procedures established by the ECN where in an application shall first be presented by the Observation Group. Once the International Group is accredited by the ECN, the group shall then submit an application form listing the individual observers with their attached signed pledges to adhere to this Code of Conduct.
- 3. The declaration and pledge of international observers' form & required documents should be duly attached.
- 4. The attached form about the details of the observers and their assignment should be filled.
- 5. Each Observer Group duly accredited in the above manner shall be solely responsible for all its support arrangements and the costs thereof. The ECN shall not be responsible for any costs incurred.
- 6. The observer should carry his/her accreditation card at all times while he/she is performing his/her functions as an observer.

1.3 Rights and Privileges of Observer Groups and Observers

1. To observe all phases of the electoral process that includes party and candidate registration; election campaign; preparation for polling; voting

process (except secrecy of the voting), vote counting, issuance and dissemination of the election results;

- 2. To observe the use of media during electoral process ;
- 3. To enjoy the freedom of movement throughout the country as designated by the Government of Nepal (The list of restricted areas will be provided to the point of contact while providing accreditation to the group);
- 4. To access at all times to all facilities (including the polling and counting centers) utilized for the electoral operation as permitted by the concerned returning officers and polling officers;
- 5. To communicate freely with all the stakeholders in the electoral process, for example: Officials of the Election Commission, voters, political parties, government officials, non-governmental organizations, civil societies, professional organizations, media, etc;
- 6. To seek information and get timely responses from all stakeholders involved in the electoral process on matters within the scope of the observation;
- 7. To access to complaints regarding any election related incident; and to the public and relevant stakeholders.
- 8. To communicate the findings of the observation in an accurate and comprehensive manner at any time.

1.4 Duties of Observer Groups and Observers

International Observers have the following duties with regard to their observation of the electoral process:

- 1. Observers shall at all times recognize and respect the customs, culture and sovereignty of Nepal;
- 2. Observer groups have a duty to brief their observers fully on the electoral process and the provisions of this Code of Conduct prior to deploying any observer;
- 3. Observers shall exercise their role with impartiality, objectivity and independence and shall at no time indicate or express any political bias or preference. Observers shall refrain from carrying, wearing and displaying any electoral campaign material or any article of clothing, emblem, badge, pictures, symbols or other items denoting support for or opposition to any political entity;
- 4. Observers shall respect the election officials, and exhibit a respectful and courteous attitude to election officials, voters and candidates;

- 5. Observers shall identify themselves immediately and cooperate with the electoral officials;
- 6. Observers shall undertake their duties in an unobtrusive manner and not interfere with the election process. Observers shall refrain from influencing or providing guidance to persons involved in the electoral process/voting;
- 7. Observers shall respect the instructions given by polling officer to limit the number of observers to enter into the polling centers in order to maintain calm and conducive environment for polling.
- 8. Observers shall observe the voting on polling day from a reasonable distance, and refrain from talking to voters inside the polling station and from asking voters about their political inclination. Observers shall respect the secrecy of the voting and not interfere with the orderly conduct of the voting process;
- 9. Observers shall abstain from adjudicating disputes, certifying results, or providing written statements as evidence to be used in relation to dispute resolution;
- 10. Observers shall not issue any disputable statement disturbing the operation of polling.
- 11. Observers should register any information or event which may be in contradiction with the electoral laws or regulations or the Code of Conduct issued by the ECN and shall immediately bring this to the attention of the ECN. While obliged to inform the Commission thereof, the observers shall refrain from intervening in the incident itself;
- 12. Observer Groups shall be accurate and comprehensive in their review of the election and must consider all factors that affect the electoral process when issuing statements and reports;
- 13. Observer Groups shall be transparent and reveal all methods used for information-gathering including facts and methodologies upon which conclusions are based;
- 14. Individual observers shall refrain from issuing personal statements about the electoral process to the public and media;
- 15. Observers shall refrain from slanderous or defamatory public statements regarding the ECN or any other electoral stakeholders;

- 16. Observers shall refrain from announcing election results issuing any statement pertaining the process and result prior to the formal announcement of result from ECN;
- 17. Observers shall maintain due secrecy on the matters pertaining to voting and counting;
- 18. Observers shall refrain from bringing, using, and carrying any arms/weapons and other restricted items
- 19. Observers shall remain in close liaison with Point of Contact and ECN;
- 20. Observer groups shall submit a preliminary report within 15 days of election and a comprehensive report within 30 days after the election result is published.
- 21. Observer groups shall not drink alcohol alcoholic beverages while performing their function as observers.

1.5 Revoking Accreditation

The Election Commission may revoke accreditation of any Observer Group or individual if the group or the observer fails to abide by the laws of Nepal or violates this Election Code of Conduct.

Call for international observers to observe "House of Representative and Provincial Election 2017" of Nepal

(First time published on 9th September, 2017)

Election Commission of Nepal (ECN) announces its call for submission of applications for the observation of "House of Representatives and Provincial Elections 2017" of Nepal no later than 30th September 2017. The terms and conditions for the application by international organizations / communities / individuals are as follows.

1. Background

The "House of Representatives and Provincial Election, 2017" is scheduled to be held on 26th November & 7th December 2017 in Nepal. The objectives of call for application are: to witness and observe the overall management of above elections and to contribute to conduct of elections in a free, fair and credible manner. Moreover, other objectives to call international organizations/communities are: to involve them in transparent electoral processes of Nepal and to develop and strengthen mutual relations with international organizations/communities in electoral management process in order to maintain the credibility of ECN.

2. Accreditation procedures for International Observers

This section contains the instructions and forms required to obtain accreditation for international observers of "House of Representatives and Provincial Elections, 2017 (2074)" of Nepal. Procedures below must be followed in order to obtain accreditation for your observation groups/organization/institution and the observers in the group/organization/institution.

2.1 Application procedures for accreditation for the observer group:

a. "Code of Conduct for International Observers" has already been approved by the Commission. Observer should carefully read the ECoC and ensure compliance of the provisions therein.

- b. Completed "Application form for Accreditation for International Observation" (enclosed) to the Observation Liaison Office (the Elections Observation Resource Centre) of the Election Commission Nepal should be submitted online.
- c. "Authorization Form for the Point of Contact" (enclosed) with one passport size photograph should be submitted with complete application form. This form will identify the person acting on behalf of the observer group with whom the Observation Liaison Office (the Elections Observation Resource Centre of ECN) will interact on observation matters. A copy of the person's valid passport should be attached herewith.

2.2 Accreditation Requirements

- f. Applicant (Organizations/Communities/Individuals) should produce evidence of registration with the relevant authority of their own country
- g. Applicant (Organizations/Communities/Individuals) should have a working experience in the field of election, electoral process, money & politics and so on.
- h. All applicants (Organizations) should fully comply with the ECoC promulgated by the ECN.
- i. ECN shall not be responsible for accreditation of application if the information provided is wrong.
- j. Election Commission of Nepal fully deserves the right of accreditation.

2.3 Terms and conditions for accreditation for the individual observers

Once the observation group itself has been accredited, the application for the individual observers can then be processed. The following documents should be submitted for each observer in order to be accredited as an observer.

- g. The completed "Declaration and Pledge of International Observer" form (enclosed) along with a passport size photograph and a copy of the passport.
- h. CV Certified by the concerned observation organization/institution.
- i. A copy of any publication related to election observation
- j. The stack of forms submitted must have a cover page on the observation group's letterhead along with the name of each observer and his/her nationality in the same sequence as enclosed in completed forms.
- k. Applicant can apply directly online on (*observer.election.gov.np*) (*For you kind information: application can be submitted after 5 days from the announcement of the notice*) and ECN will inform status of the application to the applicant. But, the applicant organization should submit hard copy evidence required to process accreditation. (A sample for the application can be downloaded from (<u>www.election.gov.np.</u>)
- 1. Group intended to mobilize their local staff (Nepali) also need to undergo the due process of accreditation.

- m. The individual applicant's application as an observer should be submitted at the same time as the observer group (See Step1) and have to wait until the group accreditation has been completed.
- n. Groups can make several submissions on behalf of individual observers if required.

2.4. The Issuance of observer accreditation cards

Once the application of individual observer has been approved by the Commission, the accreditation cards shall be prepared for each observer. Then the contact person of the observers' group shall be informed to collect the card.

Further Instructions:

- d. The contact person of the observer group should directly submit all the applications to the Observation Liaison Office of the Election Commission of Nepal.
- e. A final submission date for the above applications shall be announced at a later stage.
- f. The Election Commission of Nepal will provide an information kit of minimum information required for each observer.

Please note that the Election Commission of Nepal expects the observer groups to provide each observer with comprehensive training on electoral system and the Election Code of Conduct (ECoC) to be used for "House of Representatives and Provincial Elections, 2017" of Nepal.
